The Company has received today (Friday, August 29, 2025), a letter dated August 28, 2025 ("Request Letter") from Coromandel Engineering Company Limited ("CECL"), seeking de-classification from the 'promoter and promoter group' of the Company under Regulation 31A of the Listing Regulations.

The stake in CECL, erstwhile part of the Murugappa Group, was sold by the promoter / promoter group pursuant to the Share Purchase Agreement dated September 29, 2023. Consequent to the sale, CECL ceased to be a part of the promoter / promoter group of the Company w.e.f. December 29, 2023 and has now requested their name be removed from the Company's Promoter/promoter Group list.

Sub: Request for reclassification from "Promoter and Promoter Group" Category to "Public" category shareholder (technically de-classification considering Nil shares are being held by the CECL as on date of this request) of E.I.D. – Parry (India) Limited ("Company") in accordance with Regulation 31A of the Securities and Exchange Board of India (Listing obligation and disclosure requirement) Regulation, 2015, as amended from time to time ("Listing Regulation")

1. Background and Rationale

- 1.1 We, Coromandel Engineering Company Limited writing this letter to inform you of our intention to be re-classified to public category in accordance with Regulation 31A of the Listing Regulations. This request is pursuant to the Share Purchase Agreement (SPA) executed on 29th September 2023 between Promoters/Promoter Group sellers of Coromandel Engineering Company Limited belonging to the Murugappa Group, by way of which, their entire shareholding in Coromandel Engineering Company Limited was divested by them and consequent change in control on 29th December 2023.
- 1.2 We understand that the equity shares of the Company are presently listed on BSE Limited and National Stock Exchange of India Limited.
- 1.3 As per the latest shareholding pattern of the Company, we are disclosed as part of the "promoter group" category of the Company.
- 1.4 As on the date of this letter, we hold Nil shares of the Company.

2. Request for Re-Classification

- 2.1 In culmination of the above, we request the board of directors to take on record our request for re-classification to public category in accordance with Regulation 31A of the Listing Regulation and take all the necessary steps in this regard.
- 2.2 As required under Regulation 31A (3)(b) of the Listing Regulation, we hereby confirm that, neither we or nor person related to us:
 - a) Hold more than 10% of the total voting rights in the Company
 - b) exercise control over the affairs of the Company directly or indirectly;

- c) have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
- d) are represented on the board of directors (including not having a nominee director) of the Company;
- e) are acting as a key managerial personnel in the Company;
- f) are classified as 'wilful defaulter' as per the guidelines issued by the Reserve Bank of India; and
- g) have been categorized as a fugitive economic offender.
- 2.3 We further confirm that we do not act in concert with the Promoter/ Promoter Group of the Company.
- 2.4 Additionally, we are not privy to any price sensitive information relating to the Company and its securities.
- 2.5 Further, we undertake to comply with the requirements specified in Regulation 31A (4) of the Listing Regulation at all times.

We shall endeavour to provide all necessary information /documents s may be required with respect to the re-classification, as and when required to facilitate the process.

Accordingly, request you to please consider and approve this request for re-classification from the "promoter and promoter group" category to "Public" Category and take necessary steps in this regard.
